NO COURT SUPERVISION

730 ILCS 5/5-6-1(j)

The provisions of paragraph (c) **{“c” is Court Supervision}** shall not apply to a defendant charged with violating Section 6-303 **{DWLS & DWLR}** of the Illinois Vehicle Code or a similar provision of a local ordinance when the revocation or suspension was for a violation of Section 11-501 **{DUI}** or a similar provision of a local ordinance or a violation of Section 11-501.1 **{Stat. Summary Suspension}** or paragraph (b) of Section 11-401 **{401 is accidents involving death}** of the Illinois Vehicle Code if the defendant has within the last 10 years been:

- (1) convicted for a violation of Section 6-303 of the Illinois Vehicle Code or a similar provision of a local ordinance; or
- (2) assigned supervision for a violation of Section 6-303 of the Illinois Vehicle Code or a similar provision of a local ordinance.
