The provisions of paragraph (c) {"c" is Court Supervision} shall not apply to a defendant charged with violating Section 6-303 {DWLS & DWLR} of the Illinois Vehicle Code or a similar provision of a local ordinance when the revocation or suspension was for a violation of Section 11-501 {DUI} or a similar provision of a local ordinance or a violation of Section 11-501.1 {Stat. Summary Suspension} or paragraph (b) of Section 11-401 {401 is accidents involving death} of the Illinois Vehicle Code if the defendant has within the last 10 years been:

- (1) convicted for a violation of Section 6-303 of the Illinois Vehicle Code or a similar provision of a local ordinance; or
- (2) assigned supervision for a violation of Section 6-303 of the Illinois Vehicle Code or a similar provision of a local ordinance.
